

REACH FUNDING MECHANISMS

Country Program Grants

REACH provides larger financing to RBF schemes that strengthen country systems in specific countries
Nepal: Second country program grant in the works

Knowledge, Learning, and Innovation Activities (KLI)
Financing RBF schemes that contribute to global evidence base
19 projects funded across two rounds of proposals
Next Call, May 2016: "REACH For Reading" – Global Book Fund



REACH FOR READING: CRITERIA

Relevance to Global Book Fund goals: Reforms one or more aspects of the way books are developed, procured, produced, or distributed, using results-based financing. A focus on early grade books in underserved languages is preferred.

Technical soundness: A clearly defined theory of change, grounded in evidence, about how the intervention could impact book development, procurement, selection, production, or distribution. An emphasis on strengthening country systems is preferred.

Methodological rigor: Plans for rigorous evaluation of the intervention, which will inform the global evidence base.

Strategic opportunity for long-term engagement: Potential for scale up within country, or scope for the model to be scaled up in other countries/ regions.

Client commitment: Countries where the government and/or partners have already established reading programs.



REACH FOR READING: FAQ

What kinds of organizations can be funded?

- NGOs/Firms
- World Bank Teams
- Other development partners
- Academics

What is the maximum amount per grant?

• The maximum budget for an activity financed through this call (there may be additional calls) for proposals is expected to be \$500,000.

How will funding be managed?

• A World Bank TTL must be identified for each proposal selected for financing. Teams outside the Bank will be matched with a TTL.
